The Police Jury of the Parish of Avoyelles, State of Louisiana, met in Regular Session, at the LSU Ag Center in Mansura, La, on Tuesday, March 8, 2022, at 5:00 p.m.

On motion by Darrell Wiley, seconded by Jacob Coco, to adopt the minutes of the Regular Meeting held on February 8, 2022, printed in the "Weekly News", and mailed to all Jurors. On vote, the motion carried.

On motion by Glenn McKinley, seconded by John Earles, to accept the minutes of the Tourist Commission Meeting held on February 28 ,2022, as presented. On vote, the motion carried.

On motion by Charles Jones, seconded by John Earles, to accept the financial report offered by the Secretary-Treasurer which displayed budget/actual. On vote, the motion carried.

On motion by Charles Jones, seconded by John Earles, to keep current R.V./Travel Trailer policy in place.

On motion by Charles Jones, seconded by Glenn McKinley to claim Standard Allowance by revenue loss, for American Rescue Plant Act. On vote, the motion carried.

Juror Jacob Coco, seconded by Bobby Bordelon, to award to the low bidder Diamond B Construction, round 7 project for Road District 2, \$690,000. On vote, the motion carried.

On motion by Bobby Bordelon, seconded Jacob Coco, to pay the final request for payment to Merrick Construction for Road District 2, \$36,247.62. On vote, the motion passed.

On motion by John Earles, seconded by Darrell Wiley, approving Constance Wilson to attend a FEMA Conference in April, approve hotel accommodations. On vote, the motion carried.

On motion Glenn McKinley, seconded by John Earles, to solicit bids for a dozer and a grab truck. On vote, the motion carried.

On motion by Glenn McKinley, seconded by Bobby bordelon , to accept the apparent low bid to paint Health Unit offices in Marksville and Bunkie. The project is hereby awarded to Gremillion Painting. On vote, the motion carried.

On motion by Jacob Coco, seconded by Bobby Bordelon, to adopt a resolution recognizing March 22nd as National Agricultural Day. On vote, the motion carried.

On motion by Jacob Coco, seconded by Bobby Bordelon to pay Pan American invoice #30190, Round 7 Project Engineer fees. On vote, the motion carried.

By unanimous consent on the motion offered by Bobby Bordelon, seconded by Charles Jones to add to the agenda to acceptance of Coco Estates Subdivision. On vote, the motion carried to add this to the agenda for discussion and vote.

On motion by Mark Borrel, seconded by Darrell Wiley, upon recommendation by the Planning Commission to accept the Coco Estate Subdivision as up to standard with regulations set forth by the Parish. This motion is not accepting ownership of said subdivision. On vote, the motion carried.

On motion by Glenn McKinley, seconded by Mark Borrel, to grant authority to the Secretary-Treasurer to pay bills and waive a reading of the whole. On vote, the motion carried.

There being no further business, on motion by Bobby Bordelon, seconded by John Earles, the meeting adjourned at 5:27 p.m.
