The meeting opened with the prayer by District Attorney, Charles Riddle, followed by the Pledge of Allegiance.

President Wiley announced all items on the agenda are open for public comment. Anyone desiring to speak, should fill out a "Request to Speak" card.

Roll call by Secretary-Treasurer.

On motion by Clyde Benson, seconded by Allen Thomas, to adopt the minutes of the Police Jury Meeting held on May 14, 2024. On vote, the motion carried.

On motion by Allen Thomas, seconded by Jacob Coco, to adopt the minutes of the Tourist Commission meeting held on May 20, 2024. On vote, the motion carried.

# **DELEGATIONS:**

Representative Daryl Deshotel gave a legislative update. He informed the Jurors and those in the audience he was able to secure \$20,000 for the town of Plaucheville for a truck. Last year he requested \$3,000,000 for Recreational/Educational Complex, which was vetoed by Governor Edwards. This year during the legislative session he was able to finally secure 4,500,000 for the complex, which will be in the form of cash that requires no match from the parish. He went on to say in HB 700, 1.35 billion dollars will go towards making sure every household in Avoyelles has fiber. For road repairs, Representative Deshotel informed the Jury, in a supplemental bill the parish was awarded the following: \$255,00 for Ed Carrol Road, \$255,000 Louie Harmson Road, \$127,000 Firmin Road and \$118,000 J.B. Luke.

In addition, \$2,000,000 was secured for Capital Outlay which requires a 25% match. The coroner will receive \$100,000 for a Toxicology machine, which requires no match, and will be a huge savings for the parish, according to the Coroner, Dr. James Bordelon. \$30,000 was secured for the

Village of Hessmer for a GPR machine that will aid water systems when installing fiber optic wiring. The machine is also available for other municipalities to use.

Colby Delahoussaye with HUB International gave an update related to health insurance increase.

Mike Rachal, Administrator for AVAP School in Hessmer asked the Jury to provide aggregate for approximately 60 yards of driveway leading to the school. Juror Franks interjected, advising Mr. Rachal, he was aware and addressing the issue. Mr. Rachal thanked the jury for allowing him to speak.

Travis Ducote has been before the Jury since 1999 asking for help with a canal located behind his home that causes significant flooding to his property and 200 or more others. He stated Representative Deshotel promised a grant for drainage two years ago, to which nothing had been received. He then asked about the signage that was recently installed at the maintenance facility for the late, Charles Jones. He wanted to know who authorized the purchase. He stated he reported this to the Attorney General as he felt it was stealing. President Wiley provided an explanation. He then went on to inquire about the \$15.00 RV permit. Juror Pearce as well as District Attorney Riddle provide information as to why the permit is required.

Jenny Falls asked Jurors if they voted on the placement of the Solomon Northup statute. She specifically questioned a detailed plan of placement. She reiterated numerous times she was not against the statute, rather the placement because it will eliminate one of the oak trees on the lawn. She feared placing the large plaza would attract the homeless population and increase litter. District Attorney Charles Riddle, also a member of the Solomon Northup Committee for Commemorative Works advised Ms. Falls and Juror on October 11, 2022, the Jurors at that's time unanimously voted to install the statute. He went on to say after listening to the minutes of that meeting, the possibility of removing the tree was mentioned. In April of 2024, he along with Jacques Goudeau and Reverend Allen Holmes, also members of the Solomon Northup Committee attended the meeting and presented a detailed plan of what to expect. Others in attendance asked for the statue to be erected between the trees. It was stated by doing so, it would obstruct parts of the structure and compromise both trees. President Wiley asked the for both sides to compromise. District Attorney Riddle agreed to inquire if the relocation was possible at this point.
