On motion by Jacob Coco, seconded by Sam Pearce, to adopt the minutes of the Regular Meeting held on October 14, 2025, as printed in the Weekly News and emailed/mailed to all Jurors.

On motion by Allen Thomas, seconded by Jacob Coco, to adopt the minutes of the Tourist Commission meeting held on September 22, 2025, as presented.

Upon recommendation from the Planning Commission, a motion offered by Sam Pearce, seconded by Mark Borrel, to establish a minimum of one acre in rural areas for all new construction and all subdivisions in rural areas of the parish. All landowners that have not improved the property are grandfathered in. On vote, the motion carried.
