Call to Order

Dr. Moreau called the meeting to order at 6:00 PM

Approval of minutes of September 17, 2019 RD2 Commission meeting

Tim Bordelon read the September 17, 2019 minutes to the Commissioners and guests at this meeting, Trent Clark moved that the September 17th minutes, as presented, be voted upon for acceptance. Terry St. Romain seconded the motion. The motion passed.

Review of Financial Report

Tim Bordelon briefed the Commissioners on the current 2019 budget and spending outlook for the RD2 Commission. The complete November 26, 2019 Financial Report is attached, highlights are:

Motion to approve the November 26, 2019 RD2 Financial Report

Duane Lacour moved and Trent Clark seconded, that the Financial Report be accepted, as presented, by the RD2 Commission. The motion passed.

Orientation summary of RD2 for benefit of newly elected Police Jurors

For the benefit of the 2 Police Juror Elects, present as guests, Dr. Moreau summarized the formation of RD2, work completed since inception, estimated annual budget and near-term projects to be completed.

Problems on Round 3 Projects: Palmer Ridge Rd and James Clark Rd

The final payment to the Contractor, Diamond B Construction, continues to be held as retainage. Previously, Diamond B secured 2 bids from potential sub-contractors to seal the cracks to RD2 satisfaction. The lower bidder offered to seal the cracks for \$8,000. Diamond B requested that RD2 split this cost with Diamond B. Negotiations with Diamond B resulting in RD2 agreeing to pay an

additional \$2,000 to Diamond B, increasing the total contract cost to \$696,744.25. As a result of this increase, retainage of the final payment to Diamond B increases from \$33,443.08 to \$35,443.08.

Approaches to LA Hwy 451 pertaining to LA DOTD ongoing work

LA DOTD is currently repairing/widening shoulders in curves on Hwy 451 and will overlay the segment from LA Hwy 1 in Moreauville to the Locks in Bordelonville. The contract with Diamond B includes overlaying the intersections with LA Hwy 451 for a distance of ~25 feet from the DOTD right of way. Kevin Bordelon discussed with DOTD the possibility of extending the overlay at these intersection to cover the road surface on the wooden bridges, where applicable, with RD2 being responsible for this incremental cost. After much discussion, a feasible solution was not identified. The overlay of wooden bridges will be considered during future work on N Bayou des Glaises RD.

Update on Round 4 Road Repair Projects - Chip & Seal

The contract was awarded to Brudd Construction on August 13, 2019. The scope of work for this contract is to Chip & Seal (3 course) the following segments of roads:

Ron Bordelon updated the Commissioners on project status. Brudd has not yet commenced the work on the road segments. Immediately after the contract was awarded, Brudd Senior Management promised to begin work by end of September 2019. Kevin Bordelon has a scheduled meeting with Brudd on Wednesday, November 26th pertaining to work schedule.

Discussion on Mill Bayou/Bayou Rousseau drainage

Mill Bayou/Bayou Rousseau runs from Pete Laborde Rd to the Diversion Canal between Moreauville and Plaucheville, approximately 7.6 miles. Kevin Bordelon advised that the Levee Board has responsibility for the segment from LA Hwy 1 in Hamburg to the point Mill Bayou/Bayou Rousseau empties into the Diversion Canal, approximately 3 miles. Furthermore, the Levee Board has agreed to clean this segment during the Spring/Summer of 2020. Kevin Bordelon advised that he intends to assist the Levee Board in this effort with equipment and personnel. RD2 will wait on any action for this project until there is a need to become involved.

Next Meeting

Regular RD2 meetings are held on the third Tuesday of each month. The Commission decided to not meet during the month of December this year. Therefore, the next regular meeting was tentatively scheduled for January 21, 2020.
