## Approval of minutes of June 21, 2019 RD2 Commission meeting

Tim Bordelon read the draft minutes. Trent Clark moved that the minutes be approved and accepted into the record; Terry St. Romain seconded the motion. The motion passed.

### **Review of Financial Report**

Tim Bordelon briefed the Commissioners on the current 2019 budget and spending outlook for the RD2 Commission. The complete May 21, 2019 Financial Report is attached, highlights are:

### Motion to approve the June 21, 2019 RD2 Financial Report

Duane Lacour moved and Terry St. Romain seconded, that the Financial Report be accepted by the RD2 Commission. The motion passed.

#### **Traffic Count on Lee Chatelain Road**

Greater APPJ requested the Rapides Planning Commission to generate Traffic Count Reports on roads in Avoyelles, as directed by the APPJ. So far, the Planning Commission has accommodated request for no charge. The Planning Commission reported the following, with respect to RD2 roads:

Lee Chatelain Road - 114 vehicles/day (for 5 week days)

Pecan Grove Rd - 313 vehicles/day for 5 week days and 305 vehicles/day for 2 weekend days.

Dr. Moreau requested nominations for additional roads within RD2 from the Commissioners. Trent Clark nominated Back Step Rd in Plaucheville. Tim Bordelon nominated the eastern side of Lemoine Lane and Couvillion St (Sybil's X-ing to LA 1) in Moreauville. Dr. Moreau said he will direct the Planning Commission accordingly.

## Problems on Round 3 Projects: Palmer Ridge Rd and James Clark Rd

Both roads seem to have serious flaws, after repairs done by Diamond B. Cracks have developed and continue to widen. The final 10% of contract value to the Contractor (\$33.4k) has not yet been released to Diamond B. Punchlist items were delivered to Diamond B. The time allowed by contract for Contractor to complete the punchlist items, 45 days, has already been exceeded. The RD2 Commissioners asked Ron Bordelon to meet with Diamond B to discuss options for correcting the flaws on the two roads.

### **Action Item for Ron Bordelon**

Ron will meet with Diamond B and report back to the RD2 Commission at the Commission's next meeting to recommend a way forward.

## **Update on Round 4 Road Repair Projects**

A single bid was submitted as a result of RD2's request for competitive bids on the package of road repairs. That bid was from Brudd Construction. PanAm's estimated cost of the work was \$350,000. Brudd Construction's bid was \$346,014.97. Ron Bordelon will analyze the bid for compliance and recommend whether to award or not.

### **Broad Discussion of Drainage within RD2**

Duane Lacour recommended that RD2 begin consideration of drainage issues as well as road repairs within RD2. All Commissioners agree that drainage is a problem in RD2 and must be addressed.

#### **Next Meeting**

Regular RD2 meetings are held on the third Tuesday of each month. Therefore, the next regularly scheduled meeting is intended to be Aug 20, 2019.
