Call to Order

Trent Clark called the meeting to order at 6:00 PM

Approval of minutes of July 23, 2019 RD2 Commission meeting

Since the July 23, 2019 minutes were distributed to the Commissioners in advance of this meeting, Trent Clark moved that the July 23rd minutes be voted upon for acceptance without reading aloud. Tim Bordelon seconded the motion and that motion was approved. Terry St. Romain moved that the minutes be approved and accepted into the record; Duane Lacour seconded the motion. The motion passed.

Review of Financial Report

Tim Bordelon briefed the Commissioners on the current 2019 budget and spending outlook for the RD2 Commission. The complete July 23, 2019 Financial Report is attached, highlights are:

Motion to approve the August 20, 2019 RD2 Financial Report

Duane Lacour moved and Terry St. Romain seconded, that the Financial Report be accepted by the RD2 Commission. The motion passed.

Presentation on Environmental Permitting by Mr. Bart Pittman

Mr. Pittman reviewed the general permitting guidelines for maintaining ditches. Mr. Pittman's consulting services include physically scouting the ditches, developing the scope of work for a contractor to complete and expediting/assisting with permitting the project areas. Mr. Pittman advised that his Consultant Fee is \$105/hr. Typically, his report on a ~2 mile ditch would cost his client ~\$2,000.

Action Item for all RD2 Commissioners

The RD2 Commissioners were requested to propose candidate drainage ditches for this work and develop a priority list of drainage projects. With a priority listing, candidate ditches can be progressed with consultation by Mr. Pittman as budget funds are available.

Problems on Round 3 Projects: Palmer Ridge Rd and James Clark Rd

The final payment to the Contractor, Diamond B Construction, is being held as retainage (\$33,443.08). Ron Bordelon and Terry St. Romain met with Diamond B on location at these two roads to discuss options for correcting the construction flaws on the two roads. The conclusions reached were: 2 areas need patching and numerous cracks need sealing. Diamond B patched the 2 areas on August 16, 2019. Diamond B also agreed to complete the sealing of cracks to RD2 satisfaction for the amount of retainage and close out the project.

Update on Round 4 Road Repair Projects

A single bid was submitted as a result of RD2's request for competitive bids on the package of road repairs. That bid was from Brudd Construction. PanAm's estimated cost of the work was \$350,000. Brudd Construction's bid was \$346,014.97. This contract was approved by the Greater APPJ for award to Brudd Construction. The contract was awarded to Brudd Construction on August 13, 2019. The scope of work for this contract is to Chip & Seal (3 course) the following segments of roads:
