Motion to approve the April 17, 2019 RD2 Financial Report

Status of spraying weeds in Mill Bayou

Tim Bordelon reviewed pictures taken May 20th showing green cattails still in the Bayou. The spraying contractor, TEPCO, completed his initial spraying more than a month ago and has attempted a second spraying. He has promised to return and spray the missed patches.

Motion to request contractor bids on Round 4 Road Repair Projects

Duane Lacour moved, and Trent Clark seconded, to remove Old Hwy 1 from Round 4 Projects and include Voorhies Lane as an Add Alternate project in the big package. The projects will be bid on unit price bases, so that the projects' lengths of repair can be adjusted for the amount of funds available. The motion passed.

Motion to request competitive bids for additional Aggregate

The existing \$50,000 Moreau's Material Yard contract to provide aggregate on an as-needed basis is nearing depletion. Trent Clark moved, and Tim Bordelon seconded, to request the Greater APPJ to extend the RD2 on-demand supply contract for materials with Moreau's Material Yard by \$25,000. The motion passed with only Terry St. Romain voting NO.

Drainage in the vicinity of the South end of Bordelonville Road

Residents in the area are complaining about the slow drainage. Dr. Moreau asked Kevin Bordelon to investigate for drainage problems in the area and possibly use a small machine to clear obvious choke points.
